GETTING YOUR FAIR SHARE:

From Unjust Enrichment to Money in your Pocket



Although the law now treats common law spouses and married spouses the same in almost all respects when they choose to separate, this is not the case when it comes to dividing up property. Married spouses have a right to claim for a division of family property upon a

breakdown of the marriage. Subject to some exclusions and deductions, the value of all property existing at the date the parties separated must be shared. This is true regardless of who may legally own that property. In contrast, no such right exists for common law spouses who must divide their property based upon legal ownership at the end of the relationship. CAN YOU AFFORD TO HAVE YOUR CAR SEIZED:

Outstanding support payment gives the Family Responsibility Office the right to order your car seized.



Between April 2009 and March 2010, the province says that the Family Responsibility Office (FRO) handed out 3,965 suspensions on licenses to parents who continually miss their support payments. The FRO keeps track of all court-ordered child and spousal support payments, and under the current law, has the

right to ask the Ministry of Transportation to suspend licenses.

Starting December 1, 2010 people caught driving with a blood alcohol concentration beyond the legal limit, will have their vehicles impounded for seven days. This applies whether it is their car or a car that has been borrowed by a friend. In a new twist, the same punishment will apply for people caught driving with a suspended license for failing to pay child and/or spousal support. THE BLACKMAILER'S PARADOX

or How to Resolve Conflicts with the Intransigent Spouse During the Marriage/Relationship Or After Separation



Israel's leading expert and Nobel Prize Laureate on Game Theory as it applies to Conflict is Prof. Yisrael Aumann. His vision can be applied directly to spouses before or after separation where one party takes a wholly intransigent position and the other wants to resolve the issues on a reasonable basis.

Taking repetition into account, Game theory relates to "onetime situations" differently than to situations that repeat themselves. A situation that repeats itself over any length of time, creates, paradoxically, strategic parity that leads to cooperation between the opposing sides. This cooperation occurs when both sides realize that the game is going to repeat itself, and that since they must weigh the influence present moves will have on future games, there is a balancing factor at play.

You Don't Have To Deal With Abuse Alone



Time and again, clients have stepped across the threshold of these Offices and have become an Applicant or a Respondent in a Divorce or Common Law proceeding. Quite frequently, abusive relationships are what drives our clients to our Offices and all too often even after Separation or the institution or defense of an

Application the abuse continues. It is our policy to resolve the Application within a few short months, but the abuse can continue thereafter. We try to address that in our settlements but the root cause of the abuse usually needs to be weeded out by professional help, which is the subject matter of this article.

Abuse does not only exist if serious physical violence is present. Other forms of abuse include: emotional, sexual, social, verbal, financial, isolation, intimidation and neglect - each just as devastating as physical abuse, eroding away the victim's self-confidence and self-esteem. All abuse involves a power imbalance between the victim and the perpetrator and the perpetrator can use a variety of strategies, or tactics, to gain and maintain control over his or her partner. The element of fear is crucial to the abuser maintaining control.

There are people, however, as well as organizations that specialize in assisting victims of abuse, regardless of gender. One such organization is the Catholic Family Services of Toronto, an accredited family service agency by Family Service Ontario. With their programs and classes, they can help not only with dealing with the abuse, but how to handle a wide variety of issues such as anger management so that the abuse does not rear its ugly head again in the future.
